## Visionary Board Leader Driving Digital Transformation, Cybersecurity, and Al Innovation | Global Transformational CIO and Business Leader of a \$9B Global P&L

Lisa Davis is a seasoned board director and nationally recognized technology executive known for leading enterprise transformation and innovation at scale. With over three decades of leadership across healthcare, technology, government, and academia, she has built and modernized multi-billion-dollar organizations, turned around Intel's \$9B enterprise and government data center business, and led from the C-suite through disruption and growth. Her expertise spans AI, cybersecurity, enterprise modernization, and governance, making her a trusted advisor to CEOs, boards, and mission-driven organizations navigating rapid change.

She currently serves as an Independent Board Member for Movius, an Al-powered provider of secure mobile unified communications, and as a board member for 3Strands Global Foundation, a nonprofit dedicated to combating human trafficking through prevention education, reintegration programs, and advocacy. In 2025, she joined the Board of Advisors for Pager Health, a digital health company transforming care navigation and coordination using Al-driven engagement; Saltgrass Capital, an investment firm focused on early-stage ventures in healthcare, fintech, and enterprise innovation; and became Executive in Residence with Progress Partners, a growth-stage investment bank supporting digital-first companies through strategic advisory and capital services.

Lisa recently served as EVP and Chief Information Officer of Blue Shield of California, a nonprofit health plan with \$26 billion in annual revenue. She led and developed the digital transformation strategy to transform the healthcare system, supporting cybersecurity and leveraging digital technology, data, and AI to accelerate the delivery of modern digital services and data and analytics to improve the customer and provider experience.

Prior to Blue Shield, Lisa served as VP and General Manager of Enterprise & Government Data Center Group for Intel Corporation. There she turned around the \$9 billion failing global data center business, bringing it back to profitability after it experienced a 7-year decline. Prior to Intel, she was the CIO at Georgetown University where she led a multi-year digital transformation to enhance infrastructure and improve academic competitiveness.

Lisa spent 26 years in the federal government, serving as CIO for both the U.S. Marshals Service and the Department of Defense's Counterintelligence Field Activity. As a senior executive, she led global tech modernization and cybersecurity across classified networks.

She is a recognized expert in Cloud, Edge, Cyber Security and AI technologies and architecture. She is a champion for women in STEM fields and has chaired women's leadership groups throughout her career. Lisa has been awarded the 2023 National ORBIE CIO of the Year for Healthcare, 2022 Bay Area Orbie CIO Award for Healthcare, CIO of the Year 2022, Forbes CIO Next List for 2022; CIO Hall of Fame Award 2021.
